REPORT:

Self-assessment for Determining School and District Grades under the Anti-Bullying Bill of Rights Act

In spring of 2015, the Westampton Township Public Schools participated in a mandatory self-assessment for determining school and district grades under the Anti-Bullying Bill of Rights Act (HIB). Our self-assessment was reported publically to the Board of Education on January 4, 2016 in order to provide the BOE and the public with the opportunity to learn about the district's implementation of the ABR and address any concerns. The NJ DOE has created District and School Grade Reports of the district-reported ratings for each core element for each school and for the school district:

Holly Hills Elementary School: 7578

Westampton Middle School: 70/78

Westampton School District: 73/78

The self-reflection grades give our impression of how we have implemented the eight core elements (identified immediately below) which address all of the HIB requirements for schools.

- 6: School-Level HIB Incident Reporting Procedure N.J.S.A. 18A:37-15b(5), N.J.S.A. 18A: 37-15b(6)(a)
- 7: HIB Investigation Procedure N.J.S.A. 18A:37-15b(5) and (6)(a) and (b)
- 8: HIB Reporting N.J.S.A. 18A:17-46

An extensive rating rubric was utilized to rank implementation criteria for each of the rating categories. We self-assigned ratings based on the criteria and required documentation.

The following data was taken into consideration and utilized to verify the status of the indicators under each of the core elements:

Data Sources:

Data submitted by schools in each of the following data collection systems:

Electronic Violence and Vandalism Reporting System,

Harassment, Intimidation and Bullying – Investigations, Trainings and Programs System, and

County District School System;

The findings from monitoring under the New Jersey Quality Single Accountability Continuum (NJQSAC);

The findings from investigations of complaints of noncompliance conducted by the NJDOE's county offices of education or the Office of Fiscal Accountability and Compliance; and

Other sources of information (e.g., student conduct referrals and dispositions, student and staff attendance, student suspensions, school climate surveys, at-risk student behavior surveys).

Each core element then received a score based on the sum of the ratings for all indicators within a core element. The grade received by the school and the school district is posted for reference on the homepage of the school's website:

The report has also prompted the following reflections and strategic improvements:

Reflections and Strategic Improvements:

Our school district has conscientiously implemented and adhered to the requirements found in the Anti-Bullying Bill of Rights Act by updating policy and procedure, opening communication about bullying and anti-bullying for students, parents, guardians and staff.

During the four three years of implementation of the Anti-Bullying Bill of Rights Act, our school district has made progress in addressing and improving harassment, intimidation and bullying and the school climate and culture by disseminating information about bullying prevention, establishing procedures and timelines to report HIB, and continuing to take a strong stand about a respectful learning environment in our schools. We have infused anti-bullying lessons and assemblies into our curricula, and completing student-incident data reviews.

While completing the Self-Assessment, we learned that our school district/school has consistently demonstrated strengths in reducing the amount of recidivism regarding bullying. Observance of the "Week of Respect," disseminating information on the prevention of harassment, intimidation and bullying to students and to school staff, and compilation of reports, including reports to the superintendent and reporting to the Board of Education have been areas of strength. We adhered successfully to notification procedures and timelines in our anti-bullying cases.

During the upcoming year, our school district/school will be working towards continual reduction of bullying and we seek your involvement in improving our work by asking you to immediately report to your principal if you or your child has a problem at school.

The Self-Assessment helped our school district to identify areas for improvement including additional collaboration with the Anti-Bullying Specialist and Anti-Bullying Coordinators, increasing our repertoire of approaches to handle bullying situations, enhancing our character education curriculum, and creating a user-friendly guide for parents/guardians. Our school district will continually work to encourage trustworthiness, respect, responsibility, fairness, caring and citizenship.
